The undersigned and the Applicant agree to pay attorneys fees equal to 15% of the total principal and interest owed by the Applicant in the event that the Applicants account is placed in the hands of an attorney for collection. The Applicant agrees to pay Southern Staircase all fees that it incurs for the purpose of filing liens against property on which the Applicant has used material purchased from it. If the Applicant does not give written notice to Southern Staircase within fifteen (15) calendar days from the date of any invoice of any objections to the invoiced terms listed, the receipt thereof, that such purchase was unauthorized or any objection, then all objections shall be deemed waived. No claim asserted by the Applicant against Southern Staircase shall relieve Applicant of its obligations to make timely payments to Southern Staircase. This application and personal guarantee may only be revoked in writing sent by certified mail to Southern Staircase and said revocation will not be effective as to any purchase made prior to the receipt of said revocation.
